
## 打假聲明

The Invention registered under the said Patents is shown below:



According to Section 73 of the 《Patents Ordinance》, stocking the products which infringe a registered patent in the course of business is an infringing activity. Therefore, manufacturers, trading companies and retail stores should not act against the law and possess or sell the infringing products. For those who include manufacturers, trading companies and retail stores ignore the Hong Kong Patent rights of Kwong Fei, Kwong Fei will take aggressive legal action to stop them from engaging in any infringing activities and will claim against them for damages and costs. For years, Kwong Fei has successfully claimed against a number of manufacturers, trading companies and retail stores in China, Hong Kong, United States and Japan for infringement and **OBTAINED COMPENSATION**. In the future, Kwong Fei will invest more resources on anti-counterfeiting activities.

On 10th March 2009, Kwong Fei filed a lawsuit against the belowstated retail store for infringement of the Hong Kong Patent.
